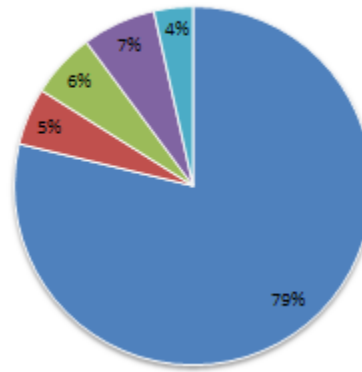

ASC Revenue 2011

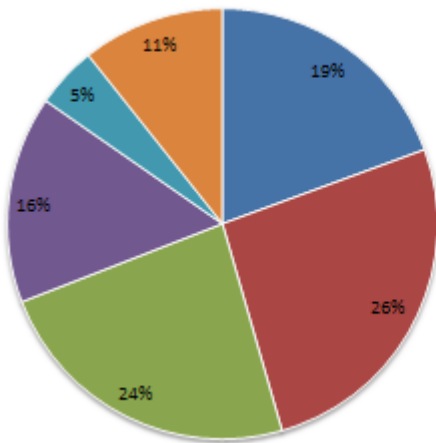


- Pledge Payment & Offering - 79%

How much should I give?

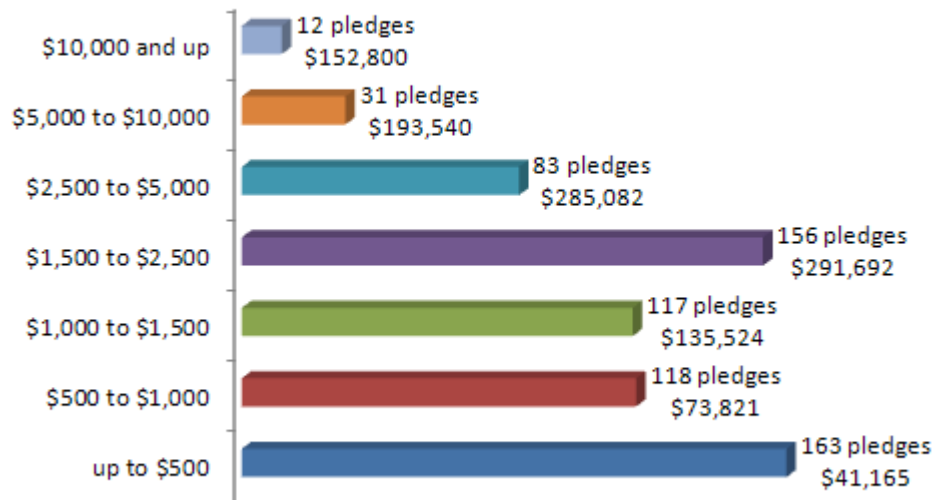
